What is the purpose of a Will?

Your Will allows you to speak after you have passed away

Your Last Will and Testament does nothing, and has no powers whatsoever while you are alive. But as soon as you die, your Will has two key functions; it allows you to make key appointments and it allows you to describe the distribution of your assets. This includes money, possessions, real estate, investments, everything that you own. You can also include bequests to charities.



YOUR EXECUTOR

Name the person with the responsibility to carry out your instructions



GUARDIANS

Name the person who will take care of your children if both parents are unavailable



DISTRIBUTION PLAN

Decide who receives what, including possessions, and sums of money

What if you die without a Will?

You already have a plan, but it's written by the government. If you write a Will, you are dictating your own plan.

If you die without a Will, the first thing to happen is general confusion. Nobody is in charge, nobody secures your assets, until somebody applies to the courts to have an estate administrator appointed. This may or may not be a person you trust.

Then, if applicable, a judge will appoint guardians for minor children. This is based on family relationship, place of residency, and financial independence. It may or not be the people that you would have chosen.

Finally, your State has a plan for the distribution of your estate. If you are married with children only a

few States have everything passing to your spouse. Most States divide your estate between your spouse and children (even if the children are very young). The State's plan for your estate rarely matches a plan written into a Will.

WHAT OTHER DOCUMENTS DO YOU NEED?

Everybody needs a Will, but you may also consider the following: Funeral Wishes - Your funeral wishes do not belong in your Will. Write this in a separate document, and simply store it with your Will. Financial Power of Attorney - Appoint a person to take care of your financial affairs if you were ever to lose capacity.

Living Will (Healthcare Power of Attorney) - Name a person to make medical decisions on your behalf, and express your wishes for treatment if you were unable to communicate for yourself.

Inventory of Assets - A critical document for your Executor or financial PoA. Allows the appointee to know what assets you have.
